I drafted the advice note [REDACTED] linked to and discussed this matter briefly with her yesterday.

I have had a quick conversation with Simon Richardson (Information Rights Manager) and have Cc him to this email chain.

Our first thoughts are to request that the names of our staff are removed from the video on the basis our policy is that inspectors are not named in the published inspection reports and that this may raise DPA compliance issues for the practice (as this could relate to our remit of compliance with the regulations and our MoU with the ICO).

I am happy to assist with drafting a letter if we want to do this.

However, I would advise that any contact is undertaken with input from provider engagement as clearly there is a risk that even this could exacerbate the situation and further impact our colleague - if they refuse to remove the names/video, my view is that unfortunately there is little we can practically do.
